



## CR7 AI — Terms & Conditions

### 1. Introduction

- Your subscription begins once your payment is successfully processed.
- The billing frequency (e.g., monthly) and the subscription fee will be displayed at checkout.

- Unless you cancel prior to the end of the current billing period, your subscription will automatically renew for the same term, and the applicable fees will be charged to your chosen payment method.
